Major Programs of Study

Masters of Business Administration (MBA)

The MBA is a flexible, part-time program that allows students to schedule courses around their busy schedules. Classes are offered in the evening with each class offered one night each week.

The majority of the MBA classes are also offered online enabling students to take the course in either a traditional classroom environment or online as best meets their learning preference, time and geographical distance from campus.

Along with the required core courses, ten areas of concentration are available to choose from.
