The University of Akron School of Law invites applications and nominations for the position of Goodyear Tire & Rubber Company Chair in Intellectual Property Law ("the Goodyear Chair") with anticipated start date as early as August 2019. The Committee is open to candidates in any area of intellectual property law, but particular experience and expertise in the area of patent law is strongly preferred. Committee review of applicants will begin on June 1, 2019 and continue until the position is filled.

Akron Law's Center for Intellectual Property Law & Technology ("IP Center") is renowned for its extensive IP curriculum, an LL.M. in IP, a joint J.D./LL.M. degree program, non-J.D. and post-J.D. certificates, rich scholarly and practical programming, and strong relationships with the national and international IP community. The IP Center was recently recognized in the U.S. News & World Report 2020 rankings as among the best in the country—tied for 41st place overall, on par with many of the best-known IP schools in the nation and tied for the top-ranked IP program in Ohio. The Goodyear Chair will serve an important role in advancing critical thinking in the intellectual property law field, within academia, the legal community, business, and industry. As a member of the School of Law faculty, the Goodyear Chair will engage in intellectual property scholarship, teach in the area of intellectual property law, and serve on administrative committees.
