BASW Criteria

Students participating in the B.H.P.P shall:

- Be a social work student major and be accepted into the program full-time with a signed contract.
- **Complete social work field practicum in their senior year.**
- **Meets all filed application eligibility requirements.**
- <u>Complete a field placement with an agency within The County of Summit, Alcohol,</u>
 <u>Drug, and Mental Health Board's (ADM) network of care.</u>
- Attend monthly meetings with Behavioral Health Campus Coordinator (meetings can be in person or via teams).
- Attend two ADM board of Summit County events (e.g., the ADM 5K run)
- Maintain a 2.5 GPA or higher.
- Obtain Chemical Dependency Counselor Assistance certification (fees associated with acquiring the CDCA are a responsibility of the student)
- Agree to work at The Summit County, Alcohol, Drug, and Mental Health site and its contracted providers for one calendar after graduation.
- The student is limited in the number of scholarships they can accept.
- **Students' field placement in the fall of 2024**

MSW Criteria

Students participating in the B. H. P. P. shall:

- **Be admitted to the MSW program and be in the micro-specialization year.**
- <u>Complete a field placement with an agency within the county of Summit alcohol,</u>
 <u>drug, and mental health boards (ADM) network of care.</u>
- Attend monthly meetings with the Behavioral Health Campus Coordinator
 (meetings can be in person or via teams).
- Attend two ADM board of Summit County events (e.g., the ADM 5K run).
- Maintain a 3.0 GPA or higher.
- <u>Complete cognitive behavioral theory certificate offered by the University of</u>
 <u>Akron.</u>
- Agree to work at The County of Summit Alcohol, Drug, and Mental Health Board site and its contracted providers for one year after graduation.
- **Characteris 1** The student is limited in the number of scholarships they can accept.
- **Students will begin field placement in the fall 2024 semester.**
